To be eligible to receive kindergarten funding the service must meet specific requirements, including provide an approved kindergarten program:

- To children who are at least four years of age by 30 June in the year they commence kindergarten
- Delivered by a qualified early childhood teacher
- Aligned with the Queensland Kindergarten Learning Guideline, or other education program approved by the Queensland Curriculum and Assessment Authority
- For 600 hours annually made up of 15 hours a week or 30 hours per fortnight for 40 weeks. Any other model must be
 approved by the Department of Education prior to commencement
